Letter from our President

Fellow MLRCA Members April 25, 2014

Every time I sat down to compose this letter to the membership, a new issue arose and I had to deal with that, as I wanted to include the most current information. Here is where we stand as of this writing.

We were told we would not be allowed to have a booth at the national show in Texas. Our booth had already been purchased and paid for and the host club had no issue with us purchasing the booth space. Randy Shumaker then verbally threatened us, harassed us, harassed the hosting club, and threatened to make things even worse for the host club if we didn't cancel our booth. At this point, we decided it was unfair to put added stress on the host club and requested a refund for our booth purchase. We have since received our refund check.

Mr. Shumaker then conversed numerous times with Chris Desurra and Kevin German and drafted a letter to the AMLRC and MLRCA members. In this letter, he insinuated Chris had the full backing of our Board in making decisions regarding our club. This was a falsehood! I am also posting a copy of that letter for all of you to read. When you read the letter, please remember that the MLRCA officers and directors do not agree to nor even knew about these demands until after we received that letter. Chris assured us he informed Randy that he did not speak for the Board and therefore could not make any decisions for the Board. He encouraged Randy to make contact with me. Until recently, I was never contacted although he had my email from previous communication about concerns I had, but Mr. Shumaker never made contact with me during this



time to address any concerns or changes he came up. Recently, Mr. Shumaker did call me. Apparently, the AMLRC Board has taken issue with the MLRCA referring to our Spring National as a "National" show. They perceived this to be offensive and antagonistic in nature. The AMLRC Board also believes their national show would have had a higher number of entries if Mini Lop breeders weren't confused as to which club held the ARBA charter. We strongly disagree, as we believe the exhibitors are intelligent and understand there are two Mini Lop clubs available for them to join. They also have the ability to exhibit at one, both, or neither annual national show.

Again, we are trying to bring all Mini Lop breeders together and the Board decided this wasn't a battle worth fighting. We are going to call our 2014 annual spring show "The MLRCA Annual Spring Show".

We chose this name because it lets people know the show will be held annually; the show will be held every spring; and it is going to be an "extravagant" event for all Mini Lop breeders and their families to attend! Thank you for your continued support of the MLRCA! Sincerely,

Secretary/Treasurer Report



The ARBA Board evidently sees us as a threat. They never thought we would last as long as we have. We were supposed to go away quietly. When this did not happen, they started to push harder. We can no longer have a booth at the ARBA convention; we cannot have a rabbit auction; we are not to have a banquet; and we have been denied a meeting room. (We will host our auction and benefit off-site.)

The MLRCA Board has been singled out even though we are ARBA members in good standing. We have not only promoted ARBA and their causes but have been the front-runners in a lot of them. I was also told that the ARBA would not allow judges to judge at any show if that club cooperates with the MLRCA. They threatened to pull their judge's licenses and not sanction the show! Yes, they would hurt the sanctioned clubs and impede on a judge's ability to earn an income in order to punish us. I also have this in writing and can prove we have received these threats! I have shared and copied this threat to the MLRCA Board.

The ARBA Board and Liaison Committee think it is only those of us on the Board who are fighting to keep our club!

They believe the membership, if polled, would tell us to fold. I believe we are doing exactly what the membership wants. We are not in competition with the ARBA chartered club and never have been. The competition is only in the minds of some of the ARBA and AMLRC Board members. This club is here to serve our members and provide them with an opportunity to further their Mini Lop experience through camaraderie because we love this breed. I encourage you to write the ARBA Board members and/or your district director and tell them to leave us alone. We are a Hobbyist Club! We are no threat to anyone. If all of you would do so and let the ARBA Board know that all they continue to do is to rub salt in an open wound, maybe they would listen. They are making matters worse instead of better. Our goal is to move forward and provide one club for all Mini Lop breeders. This will not happen until major changes are made to the constitution of the AMLRC and ARBA backs off. Let your voice be heard. Thank you.

Recent events should anger our members as much as it does your Board. After purchasing a booth for the ARBA convention in Texas, we were recently informed our club was not allowed to do this. Remember, the host club accepted our money and granted us a booth. At first we chose to ignore this bullying tactic but after contacting the host club and finding out pressure was being put on them, we asked for a refund. Hosting a national convention is hectic enough without added pressure.

Instead of using my entire article to explain all of the harassment and bullying tactics we have recently been dealing with, please go read the "Letter to the Membership" written by our president, Jason Scott. Also, read the letter written by Randy Shumaker (It is also available to the public on the AMLRC web site.) to the AMLRC. They are both printed elsewhere in the newsletter. I will take time to ask you to please contact the ARBA Board or your ARBA District Director and ask them to stop bullying and harassing us. Did you know some of the ARBA Board members; some of the AMLRC Board members, and the ARBA Liaison committee members think everyone involved with the MLRCA is an idiot? Yep, none of us have the intelligence to walk away from a club we love, disband, and join a club where

they have to actually use a portion of their constitution to tell their members to be nice to one another. How ridiculous is that? Are you aware the ARBA Liaison Committee has threatened to rescind the memberships of your MLRCA Board members? Would you like to be dealing with threats, harassment, rudeness, and verbal abuse at local shows, which are coming from some of the ARBA Board and most of the AMLRC Board? Dear Kevin:

On behalf of the ARBA Board I would like to applaud and thank you for your tremendous progress since the PA Convention on bringing Mini Lop breeders together under one club. We are very optimistic your efforts will greatly reduce the animosity between the two factions, and further everyone's goal of one Mini Lop Club. With this in mind, I would like to offer the following in writing as to the position of the ARBA Board on this matter:

- * If the AMLRC agrees to put Chris DeSurra on the AMLRC Board of Directors in some capacity as either a Director or Officer, The ARBA along with the the MLRCA, and Chris DeSurra will drop any complaints they have against the AMLRC. In addition, the ARBA and the ARBA CLC will heavily scrutinize any future complaints against the AMLRC, and give every opportunity to the AMLRC to resolve any situation before it rises to the complaint level.
- *You will, as you have committed, appoint Judy Todd to the position of AMLRC Secretary.
- *The ARBA will then remove the AMLRC from probation and thus renew the AMLRC Charter.
- *The ARBA will work with all parties to ensure that the MLRCA no longer has a booth at ARBA Conventions, and no longer holds any auctions/fund raisers at the Convention.
- *The ARBA will work to eliminate any future spring MLRCA National Shows, and if we are unable to prevent it, will support AMLRC actions to not sanction such a show with the AMLRC.

In closing, we appreciate the efforts of ALL AMLRC board members in finding a path forward toward our common goal of one, all inclusive, Mini Lop Club. We realize the road has not been an easy one, but you will continue to have our full support.

We strongly feel better days are ahead for the AMLRC and the Mini Lop breed!
